A. Call to Order

The meeting was called to order at 10:10 AM by Chairperson DeMartini with a quorum of four members present.

B. Welcome and Introductions

C. Calaveras County RFP

Mr. Doyle presented a review of the RFP process for an Exclusive Operator for 9-1-1 Emergency Advanced Life Support Ambulance Transport Services for an Exclusive Operating Area (or Areas) within Calaveras County. The Agency has been working with EndPoint EMS Consulting in the development of the RFP.

Stakeholder meetings were held with key County leaders, fire services, Mark Twain Medical Center, ambulance providers, the sheriff's department and the dispatch supervisor. Strengths and challenges in the current EMS System were identified through those meetings.

The RFP includes some system enhancements to include modernized response times and response zones; population density-based response compliance; automatic vehicle locator/mobile data terminal integration; compliance monitoring through FirstWatch; clnical oversight through FirstPass; opportunities with Copperopolis Fire Protection District; and a long term contract allowing for investment in the EMS system.

The State EMS Authority approved the RFP in early September 2019. The only change was that instead of offering a five year contract with the opportunity to extend twice for additional 3 year terms, the EMS Authority required that to be an initial 5 year contract with the option to extend once for an additional five years.

The Calaveras Board of Supervisors has approved the RFP. If approved by the JPA Board in this meeting, the RFP will be published later today (September 20, 2019). Proposals are due by December 2, 2019 and the Notice of Intent to Award is planned for December 19, 2019.
