- The County will soon receive 640 BinaxNow rapid antigen tests for COVID. Only indicated for symptomatic individuals within the first 5 days of symptoms. Following state guidance, Dr. Sergienko is recommending using these tests for healthcare workers and EMS responders; and possibly the schools.

- The County continues Alternate Care Site planning in case of a possible winter surge in flu and/or COVID that exceeds the hospital's surge capacity.
