

Effective January 1, 2017: All Emergency Medical Responders (EMR) and Emergency Medical Technicians (EMT) applicants must complete the OES Region IV MCI training.

*MVEMSA Policy # 853.00 Prehospital Training Standards
IV, B. Multi-Casualty Incident (MCI) Training (excerpt)*

Initial Training

All EMRs, EMTs, AEMTs, Paramedics and MICNs must provide proof of successful completion of the MCI Field Operations course (<http://www.mvemsa.org>) prior to initial certification or accreditation.

Renewal Training

All EMRs, EMTs, AEMTs, Paramedics and MICNs must provide proof of successful completion of the MCI Field Operations course (<http://www.mvemsa.org>) dated not earlier than 90-days prior to re-certification, re-accreditation or re-authorization.

Certification Requirements

EMR – Initial Certification

- Signed application
- Copy (front and back) of current CPR Certification taught to the curriculum standards of the American Heart Association, American Red Cross or the National Safety Council at the Health Care Provider or equivalent level.
- Copy of current driver's license or a government issued identification card
- Copy of Course completion certificate
- Payment of \$30.00 non-refundable application fee
- **Effective January 1, 2017**, we will require a copy of your MCI Field Operations course CE Certificate (<http://www.mvemsa.org>)

EMR – Re-certification

- Signed application
- Copy (front and back) of current CPR Certification taught to the curriculum standards of the American Heart Association, American Red Cross or the National Safety Council at the Health Care Provider or equivalent level.
- Copy of current driver's license or a government issued identification card
- Skills Verification form
- Copies of sixteen (16) hours of continuing education (must be CE Certificates)
- Payment of \$30.00 non-refundable application fee
- Additional payment of \$15.00 if your certification has expired
- **Effective January 1, 2017**, we will require a copy of your MCI Field Operations course CE Certificate (<http://www.mvemsa.org>) (for re-certification it must not be dated earlier than 90- days prior to re-cert)

EMT – Initial Certification

- Signed application
- Copy of current driver's license or a government issued identification card
- Copy (front and back) of current CPR Certification taught to the curriculum standards of the American Heart Association, American Red Cross or the National Safety Council at the Health Care Provider or equivalent level.
- Copy of current National Registry Certification (NREMT card AND certificate)
- Copy of your EMT training program course completion certificate
- Complete a Department of Justice and FBI Live Scan background check and attach form (must clear prior to being certified)
- Payment of \$125.00 non-refundable application fee (\$50 MVEMSA fee + \$75.00 State EMSA fee)
- **Effective January 1, 2017**, we will require a copy of your MCI Field Operations course CE Certificate <http://www.mvemsa.org>)

EMT – Re-certification

- Signed application
- Copy of current driver's license or a government issued identification card
- Copy (front and back) of current CPR Certification taught to the curriculum standards of the American Heart Association, American Red Cross or the National Safety Council at the Health Care Provider or equivalent level.
- Skills Verification form
- Copies of twenty-four (24) hours of continuing education (must be CE Certificates)
- Complete a Department of Justice and FBI Live Scan background check and attach form (must clear prior to being certified) *if not previously on file with the Agency*
- Payment of \$87.00 non-refundable application fee (\$50 MVEMSA fee + \$37.00 State EMSA fee)
- Additional payment of \$15.00 if your certification has expired
- **Effective January 1, 2017**, we will require a copy of your MCI Field Operations course CE Certificate <http://www.mvemsa.org>) (for re-certification it must not be dated earlier than 90- days prior to re-cert)
